With the support of the World Bank and the Primary Health Care Performance Initiative (PHCPI), the DGS (Direction-Generale de Santé) of the Ministry has developed a suite of clinical vignettes used to test the clinical skills of these providers and is in the process of completing in-person training for district-level supervisors to administer them to providers. The next step will be to provide continuing support to district supervisors in implementation of the program, and to develop a remote training program for providers who perform poorly on these assessments to help them rapidly improve their scores. It is proposed that the Project Echo platform and methodology be used to support both of these tasks.
